External auditor report 2021/22

On 28 September 2022, we issued a report detailing the results of our limited assurance review of Sections 1 and 2 of this authority's Annual Governance & Accountability Return for the year ended 31 March 2022. We explained that we were unable to certify completion of the review at that time. We are now in a position to certify completion of the review. The external auditor report given in Section 3 of the Annual Governance & Accountability Return requires amendments as follows:

with Proper Practices and no other matters have come to our attention giving cause for concern that relevant Except for the matters reported below, on the basis of our review of Sections 1 and 2 of the Annual Governance and Accountability Return (AGAR), in our opinion the information in Sections 1 and 2 of the AGAR is in accordance legislation and regulatory requirements have not been met. The smaller authority failed to approve the AGAR in time to publish it before 1 July 2022, the date required by the Accounts and Audit Regulations 2015, and did not disclose this by answering 'No' to Section 1, Box 1. Section 1, Assertion 4 has been incorrectly completed, as the smaller authority has stated it did not make proper provision during the year 2021/22 for the exercise of public rights. The correct response however is 'yes', and this is consistent with the Internal Auditor's response to Internal Control Objective M and with the prior year external auditor report.

Other matters not affecting our opinion which we draw to the attention of the authority:

to make proper provision during the year 2022/23 for the exercise of public rights, since the period for the exercise of public rights was less than 30 consecutive working days in length and the period for the exercise of public rights did not include the first 10 working days of July. As a result, the smaller authority must answer 'No' to Assertion 4 of the Annual Governance We note that the smaller authority did not comply with Regulation 15 of the Accounts and Audit Regulations 2015 as it failed Statement for 2022/23 and ensure that it makes proper provision for the exercise of public rights during 2023/24.
