<p>20.02 DECLARATION OF INTEREST</p> <p>Councillor D Dowrick declared an interest as a Governor at Lancaster Lane Primary School and employee of Lancashire County Council and Councillor C Bromilow as a Trustee of Cuerden Valley Trust.</p>	
<p>20.03 APPROVAL OF MINUTES DATED 11th NOVEMBER 2019</p> <p>It was RESOLVED to approve the minutes of the meeting held on 11TH November 2019 which were duly signed by the Chair.</p>
